## **Freedom House 5K Run & 1 Mile Fun Walk Logo Contest Official Rules**

### **How to Enter**

1. Entries must be submitted by email to Tracy Moran at [tmoran@freedomhousenj.org](mailto:tmoran@freedomhousenj.org). Logo entries can be originally created on computer or on paper, but all entries must be submitted in one of the computer formats listed below. The email must include the name, age, postal address, phone number, email address and a brief, two-sentence statement about his or her design.
2. No more than one (1) Entry may be submitted by any one Entrant.
3. Entries must conform to the Submission Guidelines set out below. Entries which fail to do so will be rejected.
4. The deadline for Entries is 5:00PM on January 15, 2019.
5. There is no fee to enter the Contest.

### **Submission Guidelines**

1. The purpose of the contest is to design a logo for the Freedom House 5K Run & 1 Mile Walk. The logo will be used online, in print, and on merchandise.
2. Please submit designs in black and white. The final version of the logo will need to be suitable for high quality printing.
3. Entrants should take care to ensure that their Entries are not in any way similar to existing logos or other copyrighted images. The logo must contain the words "Freedom House 5K Run & 1 Mile Fun Walk" and have a theme incorporated with the opioid epidemic.
4. The logo must not contain any other text besides that required above.
5. Designs must be submitted in any of the following formats: .jpg, .png, or .pdf (if a hard-copy design sketch is submitted, it must be scanned or otherwise rendered into one of the above computer formats and submitted). Images can be larger than, but must be no smaller than, twelve inches by twelve inches (12" x 12").
6. The limit on attachment sizes for our email is 10Mb.
7. To recap, entry will consist of: the logo attached to the entry e-mail containing the entrant's contact information and a brief, two-sentence statement about his or her design. The winning logo becomes the property of Freedom House.

### **The winning designer will receive:**

1. A commemorative award.
2. The right to use the basic logo and identify him/herself as the logo designer.
3. An event t-shirt

### **Judging and Selection of Winner**

1. The Freedom House 5K Committee will select the winning design. Their decision will be final. No further correspondence shall be entered into.
2. Freedom House reserves the right not to select a winner if, in its sole discretion, no suitable entries are received.
3. Freedom House reserves the right to disqualify any Entrant or Entry at its sole discretion.
4. The winner will be required to sign a contract assigning all ownership of the logo to Freedom House.
5. By entering, the winning entrant agrees that their name and photograph may be used by Freedom House for promotional purposes.
6. The announcement of a winner will be on January 18<sup>th</sup> via email.
